### Ds 260 Document Submission

After you complete your DS-260(s), you and each family member immigrating with you **MUST** collect the civil documents required to support your visa application. Your civil documents **MUST** be issued by the official issuing authority in your country. Please refer to the Document Finder to learn about the civil document requirements for each country.

### Civil Documents - Travel

Submit Supporting Documents. After KCC receives and processes the DS-260 application form for you and your accompanying family members, you will receive instructions for how to submit required supporting documents. Your interview will not be scheduled until you submit scanned copies of all required supporting documents, following the guidelines below.

### Submit Supporting Documents - Travel

On the Sign and Submit page of the DS-260, you will need to re-enter your DV case number without the zeros (e.g. if the case number is 2020AF0000012345, enter '2020AF12345'). Entering the full case number with zeros will generate a validation error. After submitting the Form DS-260 online, print the confirmation page.

### Submit Your Immigrant Visa and Alien Registration Application

Any person who is opting for marriage-based green cards while outside of the United States will be required to file the online form, DS-260. This form will be handled through your local U.S. Consulate or Embassy and the NVC (National Visa Center). It's like the Form I-864 - only this one is filled online. Technically speaking, form DS-260 is referred to as the "immigrant visa application" - where immigrant refers to a "permanent resident.

### COMPLETE guide to DS-260 and DS-261 in the U.S. [2020]

The DS-260 application can be submitted only online, and only after you have paid your required visa processing fees. There may be a few days' delay between the time you pay your fees and when you will be allowed to access the form.

### How to Fill in Online Form DS-260 for Consular Visa ...

When individuals for an immigrant visa or diversity visa, they are required to fill out a DS-260 form, also known as Immigration Visa & Alien Registration Application (DS 260). Form DS-260 is an inquiry from the U.S. State Department and serves a similar purpose as G325A: Biographic Information Form, which is requested by USCIS.

### DS-260: Immigrant Visa & Alien Registration Application ...

Submitting Form DS-260 does not formally execute a visa application. The visa application is not formally made until the visa applicant (s) is interviewed by a U.S. consular officer. After submitting Form DS-260 online, you must print the confirmation page and bring it to your interview. You can print this from CEAC any time after you complete your DS-260 application.
